In consideration of this agreement the Lessor agrees to lease to the Lessee the craft and equipment described herein. In the event the vessel is not returned at time specified the Lessee agrees to pay for overtime at rate of \$50.00 per each half-hour.

The Lessee agrees be on time for their scheduled rental. If the Lessee is not present within 15 minutes of their scheduled rental time the Lessee understands that he/she will be charged a re-delivery fee of \$100.00

The Lessee certifies that he/she has examined the vessel and equipment and finds it acceptable and suitable for the purpose for which it is leased. The Lessee acknowledges that the Lessor has equipped the vessel with a full tank of ethanol-free fuel. The Lessee will not add any fuel to the vessel.
